#### 3:1 Inspector

The inspector holds the highest supervision over the nation and its activities and serves as the academic link to the university.

### 3:2 Inspectors Privilege

Inspector;

- holds the position of honorary member and senior without payment of the nation membership fee,
- has the right to attend and speak at all the nation's committees,
- is a member of the board and the scholarship committee,
- has the right to take part of all the nations documents,
- is alongside accompanying company a guest at all nation events,

## 3:3 Inspectors Obligations

Inspector shall;

- follow and support the nation's activities in addition to upholding anything that furthers the interests of the nation,
- exercise general supervision to ensure that the nation's statutes are followed, inspector shall:
- participate in the nation's Landskap,
- participate in meetings of the board,
- participate in meetings of the scholarship committee to the extent prescribed in the statutes.

## 3:4 Electability

The nation shall elect the inspector among the university's teachers. Someone other than a university teacher can however be elected to the position of inspector if admitted by the university principal following a petition by the board.

#### 3:5 Election of Inspector

Election of the inspector shall be done at the end of the second official Landskap of the spring semester for a period of five years.

In case of a new inspector being elected, a special election meeting shall be held at least fourteen days prior to the Landskap.

In case of a re-election of the inspector it is preferred to take place at the ordinary election meeting.

Summons to the election meeting shall include the details of time and place of the election meeting and the Landskap. Summons to these election meetings shall be posted no later than thirty days prior to the intended day in the local press and the nation's notice board.

In relation to the election meeting the board and Senior's Collegium shall endorse or advise against proposals for candidates. The endorsed proposal shall be submitted to the Landskap where it will be taken up for decision.

The Landskap elects the inspector by secret ballot with at least a two-thirds majority.

## 3:6 Installation of Inspector

Installation of the inspector shall take place at one of the nation's formal dinners. Where the oath is taken, and the insignia and honorary member ribbon is handed over to the inspector.

## 3:7 Pro-inspector

The pro-inspector's task is to aid and support the inspector in their work.

The division of labour is mutually determined.

The nation can elect pro-inspector if necessary for a period of up to a maximum of five years according to the same procedure as when electing an inspector, however the election may take place at any other official Landskap than the second of the semester.

In the absence of an elected pro-inspector, the inspector can themselves appoint a pro-inspector for a period of no more than thirty days.

In other respects, the same regulations as for inspectors apply to pro-inspectors.
